The meeting was called to order at 7:03 by the Chair, Kate Perle. Kate gave some opening remarks about the Santa Clara Community Organization and meeting protocols, then asked for self-introductions of those in the audience. Pete Simmith from Better Eugene Springfield Transportation described an initiative that over the next few months, will engage residents of Santa Clara and River Road in a study of the River Road corridor and invited people to a town hall regarding this on November 13 at Howard Elementary School (7-8:30 p.m.). Kate introduced Pat Reilly who invited anyone who knew his wife and community activist to donate to a fund to establish a commemorative bench for her.

Kate then introduced the program – a discussion about Laurel Hill Center's plan to build a 54 unit housing development for those struggling with mental health off of Hunsaker Lane. Presenters were Devin Jenkins and Brandy Brooks from Laurel Hill Center. Using a power point they showed an aerial view of the site. They described who they serve and how they provide them with permanent supportive housing. They explained why this matters and described the service providers engaged in this. They said their vision is to provide a safe place for people who require support for their behavioral health and housing stability to help them live and thrive. They said the timeline for the project is to break ground in 2027 and have the project complete by 2029. This was followed by a question and answer session. The program ended at 7:59 p.m.

Kate opened the business meeting. Matt Vohs moved the minutes from the October 2nd meeting be approved as submitted. Terri Reed seconded. Motion passed unanimously. Kate announced the upcoming Willamette Farm and Food event. Under New Business Terri announced that again this year SCCO is partnering with St. Matthew's Episcopal Church to provide Thanksgiving meals to a dozen families of local elementary school students who experience food insecurity. Turkeys, food bags and gift cards will be provided.

Reports:

- Parks Volunteers: Jerry Finigan reported that the most recent work party by Friends
 Of Awbrey Park dealt with blackberry vines along the River Road frontage and
 Windfalls from the recent storm. Kate said the Wendover Park volunteers hold
 Work parties the 2nd Saturday of each month. The upcoming one will be
 spreading bark chips on the trails.
- Santa Clara Community Foundation: The Foundation is collecting cans and bottles
 In preparation for the Bottledrop holiday promotion. There will be a photo
 opportunity at the Schoolhouse to get a picture for the Bottledrop photo
 Contest. The Foundation has formed a fundraising committee to begin collecting
 donations for the next phase of the schoolhouse renovation. The Foundation
 continues to wait on City attorneys to complete their review of a contract to
 be agreed on before any renovation on the Schoolhouse can begin.
- The next clean-up at the Navigation Center is scheduled for December 5 (10 a.m.)
- Area Plan: Kate reported that some neighbors have formed a committee involving both RRCO and SCCO to begin implementation of the newly-adopted Area Plan.
- Land Use Report:
 - 3362 Wisteria: annexation of a .16 acre vacant lot at NW corner of Wisteria and Ginko
 - American Legion adjustment review of plan to build a freestanding ADA
 Accessible clubhouse. Parking and paved driveways behind existing historic building
 - Ava Haven adjustment review for block length requirements for access from River Road to serve their subdivision
 - Compeau River Loop subdivision final plat of Declan Orchards. 17 new lots an extension of Banton and Wedgewood streets
 - NW Family Estates—185 Ferndale—subdivision final plat of 4 lots on .93 acres
 - 301 Azalea-zone change from AG to R-1 at east end of Azalea. Public hearing November 19, 5:30 p.m.
 - 266 Lobelia zone verification. Evaluating rights to operate home based business-administrative work for a home health care business
